ICAO Separation and Airspace Safety Panel (SASP) - 23rd meeting of the working group of the whole (WG/WHL/23)

IFATCA Meeting Report

- Work was progressed on developing new lateral separation minima for RNP approved aircraft.
- Work was progressed on the ICAO Lateral Separation Circular.
- Discussions continued on the possibility of defining separation from Special Use Airspace.
- Work continued on developing a new 20 NM longitudinal separation standard for application in a data link environment and a re-evaluation of the current 30 NM and 50 NM longitudinal separation standards.
- Work was continued on the ADS-C Climb Descent Procedure.
- Work was continued on expanding parallel approach operation to technology other than ILS and MLS.
- Space-based ADS-B was introduced to the SASP for the first time.
- Work was continued on writing a manual on Global Guidance for En-Route Monitoring Agencies (EMA)
